Investor guidance notes

These notes are designed to aid users as they navigate the lp-services.info investor information website.

Outline

The website contains information in two forms – static information on the fund, its promoter, and the entities which make up its structure; and documents which can be viewed, downloaded or printed – investor reporting documents. Documents for funds you are invested in are held at two levels, the second level having two types:

- 1. At the fund level; this level will contain documents which relate to the whole fund, irrespective of how many Limited Partnerships or other entities the fund consists of; for example the Preliminary Placement Memorandum, etc.
- 2. At a Limited Partnership level;
 - documentation relevant to all investors in the particular partnership, eg the limited partnership agreement, Financial Statement etc; These can be viewed only by investors in the particular Limited Partnership
 - 2 documentation specific to you as an investor, eg capital account statements, these can only be viewed by the specific investor
